## 1. INTERPRETATION

1.1 Unless as amplified in this Purchase Agreement, or the context indicates a contrary intention or meaning, words typed in the uppercase in this Purchase Agreement and Forms shall bear the same meaning assigned to them in the General Terms and Conditions and the Agency Agreement.

1.1.1 "Bateleur Club 2000" means the Bateleur Club established in terms of the Bateleur Club Constitution dated 01 March 2000, currently being administered and managed under Series 3, 4, 5 and 6 of which the last issued Agency Contract (Series 6) will terminate by 30 June 2014;

## 2. NUMBER OF POINTS PURCHASED

Depending on the number of points purchased by the Principal, the Principal shall pay the Agent the following amounts in respect of points purchased:

Note: It should be noted that Members are allowed to purchase any number of points from 1,500 (thousand five hundred) onward. Only purchases of 6,000 (six thousand) points or more will attract bonus points.

## 3. DURATION

The Purchase Agreement shall commence on the date on which the Principal has paid the full value of the points. The maximum duration of the points purchased under this Purchase Agreement shall be 2 years (two years) calculated from the date of receipt of payment.

## 4. PAYMENT

4.1 The Principal shall, within 7 (seven) days after the date of signature of this Purchase Agreement by the Principal, pay to the Agent the Membership Payment as reflected in Form I.

4.2 The Principal irrevocably authorises the Agent to apply the Membership Payment or any balance thereof from time to time to any amounts that at any time are or will become due, owing and payable by the Principal to any of the owners or operators of the Properties arising out of or in connection with this Purchase Agreement, whether such amounts are owing in respect of Accommodation or otherwise, in respect of the use by the Member or any other person or persons, as soon as such amounts become due, owing and payable.

4.3 Payment made in respect of the Purchase Agreement will be exempted from Value Added Tax.

## 5. PAYMENT METHOD

5.1 Membership Payment may be effected by the Principal by means of one of the following methods or a combination thereof:

- 5.1.1 Transferring of existing bednights purchased pursuant to a Series 3 or 5 memberships under Bateleur Club 2000;
- 5.1.2 Transferring of existing points purchased pursuant to a Series 4 or 6 memberships under Bateleur Club 2000;
- 5.1.3 Transfer of existing points as contemplated in clause 4.5 of the Agency Agreement;
- 5.1.4 Electronic transfer
- 5.1.5 Cheque
- 5.1.6 Manual bank deposits
- 5.1.7 Credit Card via completion of Form II or via online submission at [http://www.andbeyond.com/online\\_payment](http://www.andbeyond.com/online_payment).

5.2 The Principal will elect their payment method by completing Form I attached to this agreement.

5.3 The Principal will, irrespective of the payment method selected or combination thereof, use their membership number as a reference to enable the Agent to validate receipt of the payment method selected.
